Product name: Anti-browning agent
Ingredient: Sodium erythorbate, lemon juice

3.0 Hazards Identification

This product is non-hazardous for transport. The product does not contain any hazardous materials with occupational exposure limits established.

Emergency Overview: Avoid inhalation and contact.

4.0 First Aid Measure
